YOU'RE INVITED TO AN OPEN HOUSE FOR THE INFRASTRUCTURE IMPROVEMENTS PROJECT SILVER LAKE, MINNESOTA

The proposed Infrastructure Improvements Project will be discussed at open houses to be held Wednesday, July 10, 2024, from 12:00 p.m. to 1:00 p.m., and from 6:00 p.m. to 7:00 p.m. in the Silver Lake Auditorium (320 Main Street West). This is an "Open House", so come when you can, and stay as long as you'd like. This open house is intended to provide you with an opportunity to hear about preliminary information of the proposed project and answer questions you may have. Preliminary scope maps, assessment maps, and easement exhibits will be available for review. It will also give you the opportunity to make the engineer aware of any special problems the project could address. If you received Easement Documents via mail, feel free to bring them to the open house to discuss with the City Engineer and City Staff. Easement documents could also be signed, notarized, and submitted at the open house.

Areas to be completely reconstructed include:

- Frank Street from Lane Avenue to Lake Avenue, and from Grove Avenue to East Avenue
- Center Street from Lane Avenue to Summit Avenue, and from Grove Avenue to East Street
- Cleveland Street from Park Avenue to Cleveland Lift Station, and from Grove Avenue to East Avenue
- Merrill Street from Lake Avenue to Grove Avenue
- Water and sanitary easement south of school ballpark from Grove Avenue S to East Avenue extension
- Lane Avenue from Highway 7 to Main Street
- Oliver Avenue from Frank Street to Main Street
- Park Avenue from Highway 7 to Main Street
- Tower Avenue from Main Street to Cleveland Street
- Queen Avenue from Frank Street to Center Street
- Rice Avenue from Frank Street to Center Street
- Summit Avenue from Frank Street to Center Street
- East Avenue from Frank Street to Center Street
- Lake Avenue from Main Street to Gehlen Drive, and from Highway 7 to Frank Street

Areas to receive cured-in-place pipe lining to the sanitary sewer and/or partial reconstruction include:

- Howard Street from Summit Avenue to Lake Avenue
- Main Street from Lane Avenue to Lake Avenue
- Oliver Avenue from Highway 7 to Frank Street
- Summit Avenue from Highway 7 to Frank Street

Improvements will include but not be limited to construction sanitary sewer, sanitary sewer services, water main, water services, storm sewer, drain tile, sump pump services, concrete curb and gutter, sidewalk, aggregate base, bituminous surfacing, lift station reconstruction, well rehabilitation, turf restoration, and miscellaneous items required to properly complete the improvements.
